The Local Safeguarding Children Board will meet for the first time on 5th September 2005 and so will be well ahead of the statutory start date of 1st April 2006.

All of this augurs well for the future of safeguarding children in Tameside and we look forward to meeting and working together over the next few months.

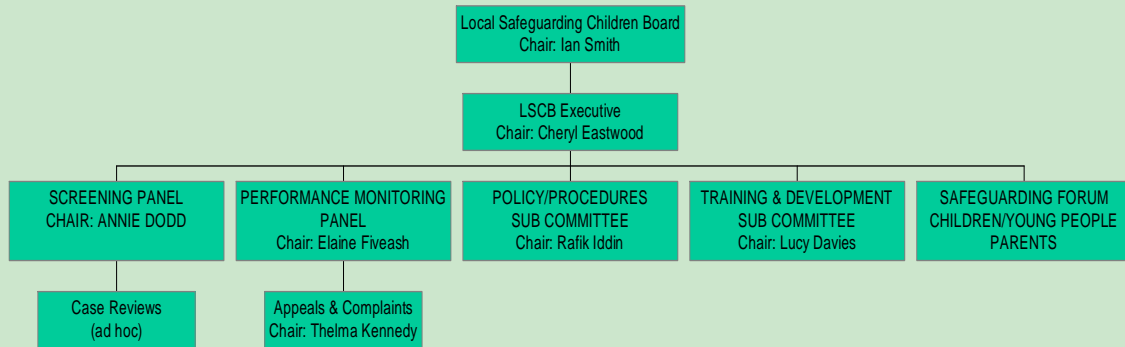

## PROPOSED STRUCTURE FOR LOCAL SAFEGUARDING CHILDREN'S BOARD



1. **The scope of the LSCB will be somewhat broader than that of the ACPC but will still maintain a focus on children in need of protection.**
2. **The Board will meet four times a year and will receive reports of activities from Sub-committees.**
3. **Sub-committees will write their terms of reference and will look at membership. All are likely to be looking for representation from across the agencies and for people who are prepared to make a positive contribution to their work.**
4. **The responsibilities of the LSCB will be:-**
  - **Local policies and procedures**
  - **Audit and evaluation of services working together**
  - **Development of effective working relationships**
  - **Agreement and understanding of definitions and thresholds**
  - **Evidence informed improvement to ways of working**
  - **Undertaking Case Reviews (part 8 of Working Together)**
  - **Multi-agency training & development**
  - **Raising awareness in the community.**

### WORKING GROUPS

Domestic Violence Working Group—Guidance was produced and is now available on the Web Page.

Children with Disabilities—Protocol has been written and will be made available on the Web Page.

Children in Need—Pilot is currently being carried out in Hattersley.

Children Missing From Home and Care—Group continue to meet to produce guidance.

Children in Custody - Guidance being written around dealing with children who find themselves in custody

Advocacy for Parents—looking at the provision of an advocacy service for parents who attend child protection conferences.

Madrassah Project—cultural project looking at providing support and training to the Muslim schools.

## ACPC Training 2005/06

The legacy of the Victoria Climbié has been a radical and far-reaching reform of all services to children. Government guidance and legislation has had a profound impact on promoting welfare and safeguarding children and will continue to do so in 2005/06 and beyond. The aim of Every Child Matters and The Children Act 2004 is to maintain what works well and develop systems to further improve services to children.

Inter-agency training and development has never had a better climate in which to grow and government emphasis on integrated working inevitably demands integrated training. The Children Act stresses the importance of a 'highly skilled and competent children's workforce. To this end "common core skills and knowledge for the children's workforce" (Dfes 2004) have been developed which outline the skills and knowledge the children's workforce should have. These skills will need to underpin all ACPC training. The areas covered by the common core include child development; safeguarding and promoting welfare; effective communication and engagement; multi-agency working and information sharing. Most of these areas are already included in ACPC training in Tameside.

Another significant focus for inter-agency training will be the common assessment framework, (CAF) due for implementation in 2006. The CAF will be a common method of assessing the needs of children and young people that can be used by the whole children's workforce.

As we develop into a statutory Local Safeguarding Children Board (LSCB), responsibility for vulnerable children and accountability for safeguarding and promoting welfare will widen, as will the remit for inter-agency training. ### EVENTS

#### Core Group Research—Feedback Session

Representatives who took part in the Core Group Research were invited back to share the findings of this research. Feedback from participants will help shape future practice and has been incorporated into the new guidance for Core Group members.

#### Fabricated Induced Illness—30th November 2004

At this half-day event Dr Mary Eminson was invited to speak to delegates on Fabricated and Induced Illness. Dr Eminson has contributed to national research and guidance in this area and works as a consultant in this field. She gave an enlightening presentation which enabled participants to consider the signs, symptoms of FII and appropriate responses when it is suspected.

#### ACPC/LSCB Development Day—20th December 2004

ACPC Members and prospective LSCB members met on this second development day in preparation for Tameside's LSCB. Tony Morrison facilitated the day in which participants explored the type of structure that would need to be in place for the establishment of an LSCB. The remit, purpose, membership and activity of the LSCB was considered with the overall aim of retaining what is good about the ACPC and "adding value" to it as it becomes an LSCB. The views of those who attended the 2004 ACPC Conference were taken into account in these development days.

#### Emotional Competence for Individuals and Organisations—21st February 2005

This day was arranged jointly by Tameside and Oldham ACPC Training Organisers. Tony Morrison facilitated the day which was attended by over 80 delegates, 45 of which were from Tameside.

Participants were encouraged to consider the emotional content in their work with children and families and the need to be emotionally competent in that work. Tony Morrison provided assessment tools and strategies for developing an emotionally competent workforce and organisation.
